FACTUAL MATRIX Pertaining to Illegal Action by Agra Police and District Administration

This Factual matrix is placed on record by the Radhasoami Satsang Sabha, Dayalbagh, Agra by way of clarification of its stand and also for information of the knowledgable citizens of the entire globe relating to the unfortunate events deliberately and systematically schemed and planned by the District Administration and police of Agra to assist the vested interests and Colonizers in their attempts to illegally trespass and grab the agricultural fields and other lands of Radhasoami Satsang Sabha, Dayalbagh and to carve out roads illegally through the said fields for their selfish interests.

- 2. The Sabha asserts that they are owners and have been in absolute possession and enjoyment of the vast extant of agricultural and other lands for more than 80 years in Agra and surrounding villages. The Sabha is in possession of all the documents of title for their aforesaid properties which include the Khataunis and revenue records maintained by the Government. Unfortunately, the District Administration, for reasons best known to them are showing a blind eye to the said documents. Some of the media persons and Newspapers are also getting influenced by the colonizers and are publishing false information in the papers thus misleading the Government authorities as well as the citizens and innocent Villagers.
- 3. Inspite of the fact that the title and possession of Sabha is supported by the Government records, even to the Knowledge of the Government officials, yet without any prior notice, on 23.09.2023, the District Administration, Agra along with huge Police force armed with Lathis and

Rifles trespassed and demolished the Entrance gates of agricultural lands of Sabha at several places and also the Holy Samadhi of 7th Revered Leader of Radhasoami

Faith, Dayalbagh, Agra, Dr. Makund Behari Lal Sahab injuring the religious sentiments of several lakhs of followers of Radhasoami Faith.

- 4. Again on 24.09.2023, the Police force came to the Gate of the private road leading to the (Ex-)Tannery* Agricultural Fields of Sabha at around 5.00 p.m. and attacked the peace loving and innocent Satsangi volunteers doing sewa in the fields, including ladies and children and beat them with Lathis. The men in uniform abused, manhandled and beat the helpless Satsangis women and children indiscriminately. The District Administration and Police did not heed to the appeals made by the Sabha authorities to show restraint and not to beat the Satsangis. The authorities were repeatedly reminded by the officials of Sabha that the conduct of administration amounts to violation of the orders of the Hon'ble High Court of Allahabad and Local Courts at Agra but in vain. Presently, more than 75 Satsangis suffered serious bleeding injuries and are being treated at Hospitals. The District Hospital Authorities at Agra, acting under the instructions of District Administration and Police refused to entertain the Satsangis who suffered grievous injuries during the Lathi charge by the Police.
- 5. The Sabha is taking recourse through Courts of Law only and are not resorting to violence even after such shocking provocation.
