Applications are invited from Indian Nationals who are bright and motivated with established record of high quality research and commitment to teaching and to conduct multi-disciplinary research for position at the level of Assistant Professor (Research)/Post-Doctoral Fellows in the Departments of Physics & Computer Science, Electrical Engineering, English, Psychology, Mathematics, Chemistry, Zoology, Music and any interdisciplinary area of interest as per Vision 2031 of the Institute.

No. of Posts: The number of position is open to availability to scholarly applications. However, maximum number of posts shall not exceed 5 at any given time.

Eligibility: Scientists and scholars with excellent track record possessing a Ph.D. degree from a reputed educational institutions.

Duration: The initial appointment shall be for one year which can be extended to maximum of a three year term. There shall be a mandatory review at the end of each year.

Salary: Consolidated emoluments shall be between Rs.40,000/- p.m. to Rs.50,000/- p.m. In the first year consolidated emoluments shall be Rs.40,000/- p.m. which may be raised to Rs.45,000/- p.m. after a review and on the basis of satisfactory performance in the second year and that of Rs.50,000/- p.m. during 3rd year.

Applications are invited for **Chair of Excellence in “Quantum Information & Consciousness”**. The Quantum – Nano Systems Centre is a multidisciplinary Centre at Dayalbagh Educational Institute.

A CHAIR of Excellence in “Quantum Information & Consciousness” Studies at the Centre of Quantum and Nano Systems Research and Consciousness Studies has been created by the Governing Body of the Institute with financial support from the Association of Alumni of Dayalbagh Educational Institutions to promote excellence in research studies in the area of Quantum Information & Consciousness. The Centre is equipped with a magnetically shielded room with SQUID Gradiometer and a fMRI is likely to be procured soon. The Chair shall be responsible for exploring novel combinations in the interdisciplinary facets of Science, Social Sciences and Medicine etc for deeper understanding of Science of Consciousness.

Eligibility: Persons of eminence and wide ranging experience not below the rank of Associate Professor engaged in active research in the cross emerging disciplinary fields of Quantum Physics/ Nanotechnology/ Systems Science/ Theology/Nano Science/Consciousness Studies are eligible for appointment .

Duration : The initial duration of Chair shall be of 3 years but may be extended. Chair recipient must take up the assignment within 3 months of receiving the appointment.
