Sealed tenders are invited from reputed Companies/Societies/Agencies for cleaning of toilets and urinals and other cleaning related work, by the suitable, trained, disciplined and dedicated Personnel on outsourcing basis for a period of one year on the following terms & conditions:

<b>We have 44 Acres with building in which all the toilets and urinals are to be cleaned. The built area includes the following:</b> <b>1. Six Faculties</b> <b>2. Three Colleges</b> <b>3. ### **TERMS & CONDITIONS**

1. The contract will presently be for one year and can be extended further with mutual agreement.
2. The Bidders should have at least three years experience or they should get a certificate of reliability from a person of eminence.
3. The contract can be cancelled if any irregularity or unsatisfactory performance is found during the contract period.
4. **The Contractor agrees and undertakes that he will follow and observe all rules and regulations and Laws of the land applicable to them and their workmen which include inter-alia Contract (Labour Regulation and Abolition Act.), Payment of Wages Act., Minimum Wages Act., Employees Provident Fund and ESI Act., Bonus Act. Etc.**
5. **The Contractor will allocate, supervise and control the work of his concerned labour deployed by him.**
6. **The Contractor** shall raise the bill on monthly basis and shall be paid through RTGS/NEFT after making necessary statutory deductions, if any.

Or

**The Principal employer shall ensure the presence of his authorized representative at the place and time of disbursement of wages by the Contractors to workers and it shall be the duty of the Contractor to ensure the disbursement of wages in the presence of such authorized representative. The authorized representative of the Principal employer shall record under his signature certificate at the end of the entries in the register of wages or the Register of wages – Cum Muster Roll as the case may be in the following form:**

**“Certified that the amount shown in the column no ..... has been paid to the workman concerned in my presence on ..... at.....”**

7. **No wage period shall exceed one month.**
8. **Where the employment of any worker is terminated by or on behalf of the Contractor the wages earned by him shall be paid before the expiry of the second working day from the day on which his employment is terminated.**
9. Number of personnel may vary according to the requirement from time to time.
10. The security service is required round the clock i.e. 24 hours and the security guards shall be required to work on shift basis.
11. Trade License/Company/Society Registration No.
12. VAT / Service Tax Regn. No.
13. Income Tax PAN No.
14. Firm's Bank A/c full details (as per Mandate Form)
15. Bidder must follow the applicable laws in force.
16. Bidders are requested to quote rate per person with breakup all taxes in the recognized Accounting units otherwise the quotation will not be accepted. Bidders must indicate if their rate is inclusive of Service Tax / others taxes.
17. In case the opening date happens to be holiday, tender will be received and opened on the next working day at the same time and same place. Quotation received after the closing date will not be entertained and revision in the price will render the bid invalid. Quotation should indicate clearly the period of Validity, preferably not less than 45 days.
18. Bids will be evaluated after equated comparison of offers upon calculating all tax/ duty/ cess/ surcharge/ discount and other charges with rates and non-compliance of technical and commercial terms will render a bid liable for rejection.
19. An exemption Certificate from the Income Tax Authority if any, be submitted within one month otherwise the Tax would be deducted at the applicable rates.
20. Bidders will have to submit Bills to this office in triplicate duly pre-receipted (and stamped for amount over Rs. 5000/-) and supported by the relevant documents for audit and payment direct to your bankers through RTGS/NEFT. Generally, payments can be expected within one month.
21. The Institute is not bound to accept the lowest rate or any other offer and the acceptance of the offer is entirely at the discretion of the Committee.
22. The Institute reserves the right to select / reject and to revise or alter the Terms and Conditions before acceptance of any tender and accept or reject any or all tenders, wholly or partly or close the tender without assigning any reason whatsoever.
23. The Bidder shall be required to submit the amount of Earnest Money Deposit (EMD) mentioned in the Notice Inviting Tender

which is refundable and a non-refundable tender fee for an amount of Rs 200/- (Rupees two hundred only) by way of demand drafts. The demand drafts shall be drawn in favour of “Registrar, Dayalbagh Educational Institute, Agra” payable at Agra. The demand drafts (validity 45 days beyond final bid) for earnest money deposit & tender fee must be enclosed in the envelope containing the bid.

- a.) The firm(s) that are registered with the National Small Industries Corporation (NSIC) / or Small Scale Industries (SSI) are exempted from furnishing the EMD. Self-attested photocopy of the valid registration certificate must be enclosed with their bid.
  - b.) The demand drafts for EMD & tender fee must be enclosed in the envelope containing relevant document and super-scribed with tender number and due date of submission on it. Any envelope containing relevant document is found without the demand drafts of EMD and tender fee will be rejected. The Institute will not be liable to pay any interest on such an amount. The EMD shall be forfeited, if the Bidder withdraws its bid during the period of validity of Tender.
- 24 Arbitration and Laws: In case of any dispute or difference arising out of or in connection with the tender conditions / order and Contract, the Institute and the Supplier will address the dispute / difference for a mutual resolution failing which, the matter shall be referred for arbitration to a sole Arbitrator to be appointed by the Institute. The Arbitration shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the venue of arbitration shall be at Agra only. The resolution of the Arbitrator shall be final and binding on both the parties.
- 25 Jurisdiction: The courts at Agra alone will have the jurisdiction to try any matter or dispute between parties arising out of this tender /contract. It is specifically agreed that no court outside and other than Agra court shall have jurisdiction in the matter.
