- 6) Bidders should quote rates as per details/specifications mentioned in notice inviting Tender. The Institute reserves the right to place order for each job to single/separate vendor(s) if necessary.
- 7) Bidders should quote rates on FOR/Free Delivery at the sites specified in the Notice inviting Tender, inclusive of all charges else should mention estimated cost of packing, forwarding, insurance and freight by Rail/Road/Post etc. as the case may be.
- 8) Bidders must indicate if their rate is inclusive of VAT/Sales Tax and /or Excise Duty.
- All equipment must be compatible with Indian electrical standards and codes. Engineering documentation on the physical sizes and weights of all major and minor components must be submitted.
- 10) Quotation received after the closing date will not be entertained and revision in the price will render the bid invalid. Quotation should indicate clearly the period of Validity, preferably not less than 45 days.

- a. - b. The demand drafts for EMD & tender fee must be enclosed in the envelope containing the technical bid. Any technical bid is found without the demand drafts of EMD and tender fee will be rejected. The Institute will not be liable to pay any interest on such an amount. The EMD shall be forfeited, if the Bidder withdraws its bid during the period of validity of Tender.
- c. In the case of Technical bid the EMD of the Bidder, who's tender has been accepted, will be returned on the submission of the performance security. In case successful bidder refuses or neglects to execute the order or fails to execute the order within the time frame as specified by the Institute the EMD of the shall be forfeited. After the award of the contract to the successful bidder, the EMD of the unsuccessful Bidder(s) will be refunded within 30 days.
- 20) Excise Duty: We are exempted from payment of Excise Duty under notification No.10/97 – Central Excise dt. 01.03.97 issued by Ministry of Science & Technology, Govt. of India. Hence, the offer shall be submitted accordingly the bidders should not include the Excise Duty in the quoted price, which can put them into a disadvantageous position. They should however, quote separately the percentage/quantum of excise duty applicable.
- 21) Customs Duty: In case of Imported Items, please note that we are exempted from payment of Customs Duty in terms of Notification No.51/96-CUSTOMS dated 23.7.1996 as amended from time to time. Issued by Ministry of Science & Technology, Dept. of Scientific and Industrial Research, Government of India, we are eligible for concession of Custom duty. Quote to be given in US Dollar for direct import by the customer. Bidder should clearly state if the quote is CIP, FOB, or Ex Works. Preference would be for CIP/CIF. In case of FOB or ExW quote, clear estimates of overheads in freight forwarding, insurance etc may be quoted separately.
- 22) Arbitration and Laws: In case of any dispute or difference arising out of or in connection with the tender conditions / order and Contract, the Institute and the Supplier will address the dispute / difference for a mutual resolution and failing which, the matter shall be referred for arbitration to a sole Arbitrator to be appointed by the Institute. The Arbitration shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the venue of arbitration shall be at Agra only. The resolution of the Arbitrator shall be final and binding on both the parties.
- 23) Jurisdiction: The courts at Agra alone will have the jurisdiction to try any matter, dispute or reference between parties arising out of this tender / contract. It is specifically agreed that no court outside and other than Agra court shall have jurisdiction in the matter.
