COUNSELING FOR ADMISSIONS 2025 – 2026

1. Report for counselling in **FACULTY OF COMMERCE, DEI** (entering DEI from Gate No. 5) between **10:00 am and 02:00 pm** on **31st July 2025 and 1st August, 2025**. All candidates must come wearing masks and headgear.
2. Only the applicant will be allowed at the counselling session, and **no other person** / representative will be permitted in lieu of or to accompany the applicant.
3. The applicant produces all his/her admit card, relevant original certificates and testimonials, including latest caste or any other relevant certificate for admission against reserved category seats (SC/ST/OBC/PWD) etc. for further verification. In case of any discrepancy being discovered at any stage, the applicant may be disqualified, and his/her admission will be cancelled.
4. If admitted, the applicant registers and deposits the fees as prescribed in the prospectus, before the deadline notified at the time of registration, but in no case exceeding three days after the date of counselling. For any clarification regarding the fee, please consult the office of Dean Faculty of Commerce.
5. The Transfer/Migration certificate issued by the Institution last attended must be submitted as per the details provided in the Prospectus.
6. If admitted, the applicant starts attending regular classes from the date notified by the Faculty of Commerce in notice board of the faculty. If he/she is absent for more than seven days in the first two weeks after commencement of regular classes, it will be assumed that the candidate has withdrawn from the programme.
7. Applicants admitted are advised to bring a recent passport size photograph at the time of their registration for affixing on the enrolment form.
8. The income certificate certifying parental income issued by competent authorities must be submitted by all admitted candidates within 14 days of registration.
