The applicants should also fulfill the following conditions:

1. The applicant reports for counseling between 9:00 am and 3:00 pm on **14<sup>th</sup> September 2021**.
2. Only the applicant will be allowed at the online counseling session and **no other person / representative** will be permitted in lieu of or to accompany the applicant at the time of counselling.
3. The applicant produces his/her original certificates and testimonials, including latest certificate for admission against reserved category seats (SC/ST/OBC/PWD), etc. for further verification. In case of any discrepancy being discovered at any stage, the applicant may be disqualified for admission.
4. Once the seat is confirmed by the Institute, the applicant should register and deposit the fees as prescribed in the prospectus, before the deadline notified at the time of registration, but in no case exceeding three days after the date of registration. For any clarification regarding the fee, please consult the respective Deans of the Faculty/Principal of the College.
5. After depositing the fees and completing his/her registration, the applicant enrolls himself/herself in the Institute on the registration date. The Transfer/Migration certificate issued by the Institution last attended must be submitted as per the details provided in the prospectus.
6. If admitted, the applicant starts attending regular classes from the date notified at the time of registration. If he/she is absent for more than seven days in the first two weeks after
