In case of any discrepancy being discovered at any stage, the applicant may be disqualified.

The applicant will have to deposit the Module fee of Rs. 750/- and register before the deadline notified at the time of registration, but in no case exceeding three days after the date of registration. The module fee to be deposited online through State Bank of India Portal and the fee submission procedure is given on the Institute website under the link "Collection of 1st semester fee from newly admitted students".
