- 10. The Academic Council noted that the Research Degree Committee of the Institute has approved registration of 18 students in the Ph.D. programme of the Institute during the period from 30.11.2014 to 15.4.2015 (Appendix-II).
- 11. The Academic Council noted the minutes of the meeting dated 2.1.2015 of the Standing Committee of the Academic Council (Appendix-III) regarding the following:-
  - (i) recommending to approve the award of degree of Ph.D. to some students,
  - (ii) created a Department of Pharmacy in Faculty of Science to render technical education to students and authorized to the Registrar to deal matter with AICTE for other necessities.

Members further noted that AICTE has not approved the course "Diploma in Pharmacy".

12. Members unanimously resolved that only one new course will be introduced per semester to begin with. Based on the feedback of the faculty and students, further action in the matter shall be taken up in a phased manner.

## Any other Items:

13. Considered nominating a member on the Governing Body of the Institute from amongst the members of the Academic Council specified under Rule 13(c)&(d) as required under Rule 11(g) of the Rules of the Institute, for a term of three years w.e.f. 1.7.2015, as the term of the present nominee Professor Ravi Sidhu, Professor & Head of the Home Science Department has ended on 13.5.2015.

Resolved unanimously that Prof. Urmila Anand, Head, Dept. of Sanskrit, be and is hereby nominated as the nominee of the Academic Council on the Governing Body of the Institute for a period of three years w.e.f. 1.7.2015, as required under rule 11(g) of the Rules of the Institute.

- 14. The Academic Council noted the minutes of the Standing Committee of the Academic Council dated 30.4.2015 (Appendix-IV) regarding starting commerce as an optional subject in High School and Science stream in class-XI (Intermediate) from the session 2015-16 at Soami Nagar Model School, New Delhi.
- 15. It was discussed during the meeting that course 'Introduction to Computers' taught in the Faculty of Arts, Commerce, Education & Social Science should have a common course content & taken up by Head, Computer Centre.

Resolved that above suggestion be implemented from the current session 2015-16 and Dr. Ratan Saini, Head, Computer Centre will teach this course.

16. The proposal on 'Daily Home Assignment' to students was considered. This assignment would be treated equivalent to one Class Test. Such Daily Home Assignment would help students to connect with the course content and in the end it may prove to be an overall better learning experience for students. It will replace one of the existing Class Tests.

Resolved that the proposal of Daily Assignment to students for all the programmes is approved from the session 2015-16.

17. The members desired that there should be a practice to implement a midsemester review process to provide students with feedback on their academic performance midway through the semester term. Similarly, members were of the view that Key Performance Indicator (KPI) and Faculty Activity Report (FAR) should be aligned.

19. Considered inclusion of electives in skill development for class VI onwards. The skill development programmes will help students of class VI onwards to discover their own potential and strengthen the skill in that area.

20. Considered the matter for restructuring the undergraduate courses to contribute to the students' liberal education with a multiplicity of combinations involving Maths and Economics or Maths and Biology.

Resolved that above proposal be adopted for implementation from the session 2015-16.

21. Considered for implementation of Yoga courses alongwith compulsory sports & games.

Members desired that Yoga is an important constituent of life and is beneficial for the students.

Resolved that Yoga Classes be regularly conducted with the sports & games classes from the session 2015-16.

22. Considered the matter of stepping up awareness programme for "Intellectual Property Rights" and "Patent Filing" across the Institute.

Resolved that a committee comprising the following members be and is hereby constituted to submit report :-

- (i) Prof. A.K. Saxena, Dean, Faculty of Engineering Convener
- (ii) Prof. Sanjeev Swami, Head, Dept. of Management, Faculty of Social Sc.
