b) The funds received are too meager to provide efficient services for UG, P.G. and research programs, resulting discontinuation of some important Journals and e-journals. The funds sought will be used to procure back volumes also.

c) Central Library also wish to establish E-library for which eBooks and e-journals required to facilitate its users.

JUSTIFICATION:

- a. The central library required a server, three scanners including special book scanner, software and other accessories with manpower to start the work of **institutional repository (Digital Section/E- Library)** to facilitate the users of DEI libraries. For the purpose library also require software, network and accessories with skilled manpower. (Point 1, 2, 3 &17).
- b. The 15 computer systems of library are with old configuration and required up-gradation to facilitate internet, e-journal and e-resources facilities to the users of libraries. The central Library also require 20 new pc for all libraries users as the strength of users increased now. Central Library also required a LCD projector as time to time it required for presentation of library services, orientation to the users of library. (Point 4,5 &10)
- c. Central library maintains library server itself and there is no cooling system for the server of DEI libraries. Central library required a solar ac for cooling the server of library. Central Library also require solar backup cooling for its users. (Point 11&16)
- d. The present photocopier Canon IR 2200 was purchased in Central Library in 2004-05 session, now machine become 10 years old and its parts not available in the market for repair and maintenance. Central library requires a heavy duty photocopy machine to facilitate the users of libraries. The central Library also require one new water cooler for drinking water facility to its users in additional to existing water cooler (Point 12-13).
- e. The present DVR and CC cameras not covers all area of DEI libraries so library require new 4 NVR with 30 Cameras (IP Based) for vigilances for all DEI libraries. (Point -14-15).
- f. The DEI libraries have only one vacuum cleaner, which is not sufficient for all libraries so DEI libraries required 4 Vacuums cleaner to remove dust and insects from books etc. (Point-9)

JUSTIFICATION:

The present building of Central Library is not sufficient as user's strength increased with new courses, beside these, library is also engaged in Shodhganga, Shodhgangotri project of INFLIBNET UGC. There is no separate reading room for user and there is not Digital Section and Cyber lab for users in the library. So, Central Library is required extension of present building minimum 700 Sq. meter to cater the needs of users.

6. LIBRARY LATE BOOK FINE:

The present fine is 50 paisa per day for fifteen days and after that Rs 1 per day. The DEI Library Working Committee resolved that late fine should be Rs 1 per day from the first day instead of 50 paisa per day with immediate effect and notice should be displayed on notice board of all DEI libraries. This is to restrict students to return books in time to facilitate other users to get benefitted by the books.

7. PRINTING/PHOTOCOPY RATES:

The member also discussed that rates of impression of photocopy should be reviewed and committee also discussed that library should charge for printing services of library to avoid misuse of the services. Here, Incharge central library is authorized by the library committee to fix the charge of printing impression but the charge should not be more than market rate, and get approval of Chairman DEI Library Committee.

8. COMPUTERIZATIONS/SUPERVISION OF TECHNICAL COLLEGE LIBRARY:

The Library committee members discussed the matter of computerization/ supervision of TC library under Incharge of Engineering Faculty Library. For the purpose library committee resolved that one staff (Clerical having knowledge of library) should be provided to TC library for smooth working & computerization. It is also resolved that a proposal of requirements for up-gradation should be sent to the Principal, TC through Incharge, CL and Chairmen Library Committee. 10. DEI Library Committee also recommended the renewal of 12 Journals of NISCAIRS-CSIR, New Delhi for the year of 2015-15 for Rs 32000/- approx. from UGC Maintenance Allocated Grant.

11. WINDOWS OS LICENSE FOR LIBRARIES:

The committee member also resolved that a proposal of requirement of windows OS License should be sent to Prof C. M. Marken as Library have no such License.

12. WRITE-OFF BOOKS

It is also resolved by the Library committee that concerned libraries prepare a list of old, unused and damaged books for write-off and put this list in next meeting of Library committee. Faculty/Departments which have departmental library are also requested to take the work of stock verification of all transferred books and make sorting of books (unused, old, outdate, damaged etc) and submit list of books (with physical book) in next meeting of Library Committee. 2.3. Building Extension

The Committee members also discussed, observed and resolved that there is acute shortage of space in all DEI Libraries. Meter extension in North Side of Central Library as the G. B. of the institute approved the extension of Central Library vide its resolution no 63 at Sr No 7 on dated 03-10-09 but building could not extended to yet). The estimate of extension may be got from Works Department of DEI.

2.4. Staff Requirement

There is an acute shortage of staff in Central Library as 4 staff position are vacant due to transfer of Mr B. P. Singh, Sh Ajay Kumar Prof Asstt deputed at Amritsar, Sh D. C. Sharma Retired and Mr Pooran expired on 29-07-18. Library works (Data Entry Maintenance, Book Maintenance, Barcode, Shodhganag work, Digital Institutional Repository and Digitization of Rare Books) are going to pending.

The Members of Library Committee strongly recommended that 4 staff should be provided to Central Library in additional 2 staff Clerical Grade (Computer Operator). The Member also recommended that one Clerical Staff should be provided to Education Library.
