

### रिपोर्ट

- ड्राइंग एण्ड पेन्टिंग विभाग से शोध छात्रा अपर्णा श्रीवास्तव का कैमरा दिनांक 24.08.15 को चोरी हो गया।
- वह कैमरा 10.09.15 को प्रिया सिंह (III Semester) के पास से प्राप्त हुआ।
- संकाय की अनुशासन समिति के सदस्यों (प्रो. लवली शर्मा, डा. स्वामी प्यारी कौड़ा एवं डा. नमिता त्यागी) एवं संकाय प्रमुख की उपस्थिति में दिनांक 11.09.15 को मीटिंग हुई जिसमें छात्रा का पक्ष रखा गया, जिसमें उसने कैमरा चोरी की बात को स्वीकार नहीं किया एवं कहा कि कैमरा मेरे भाई ने दिया है, जो उसके साथ था। भाई से पूछने पर उसने कहा कि उस कैमरे से उसका कोई सम्बन्ध नहीं है। उसने इस बात को लिखित में भी दिया है।
- पुनः एक मीटिंग 12.09.15 को की गयी, जिसमें छात्रा के माता-पिता के समक्ष विद्यार्थी के विचार रखे गये। छात्रा ने उस दिन यह बताया कि उसे यह कैमरा पड़ा मिला था।
- अंततः छात्रा ने यह स्वीकार किया कि चोरी उसी ने की एवं लिखित रूप में माफी भी माँगी।
- क्योंकि छात्रा ने यह गलत कार्य किया एवं उसने प्रारम्भ में स्वीकार भी नहीं किया, तथा विभाग की एक अन्य महत्वपूर्ण sheet चुराने के सम्बन्ध में भी इसे दोषी पाया गया था। कला संकाय की अनुशासन समिति द्वारा निम्न बिन्दु प्रस्तावित किये जा रहे हैं:-









### Minutes of the Discipline Committee Meeting

- 1 Meeting was attended by Prof. V. Nigam (Dean) Prof. K.C. Vashishtha (HOD), Prof. N.P.S. Chandel (Proctor Faculty of Edu.), Dr. G.P. Satsangi (DEI Proctor), Dr. Lajwanti (Proctor F/o Edu.) & Sona Ahuja(Proctor F/o Edu.)
- 2 Dr. T.K. Rao was asked to explain the incident.
- 3 Dr. Amit Gautam & Dr. RLN Simha were also inquired about the incident as it happened before them they reported that allegations written by Mr. T.K.Rao were partially correct and Mr. Pravendra Singh Birla Misbehaved with Dr. T.K. Rao.
- 4 Mr. Pravendra Singh Birla was also asked to explain the incident.
- 5 Committee found that Mr. Pravendra Singh Birla misbehaved with Dr. T.K. Rao.
- 6 Candidate has apologized in writting and orally before the committee members.
- 7 Following punishment has been recommended by the committee unanimously.
  - a. A warning letter to be Issued to Mr. Pravendra Singh Birla.
  - b. 10 days social service of 1 Hour every day in Faculty of Education that will be supervised by Faculty of Education Proctors.




