Vishal Saini v. PIO, Dayalbagh Educational Institute

FACTS:

2. The applicant files the RTI application on 24-02-2015 seeking information regarding UGC funded OBC employees, log book of buses of DEI, last 5 years Chambal Sand Purchase etc. The PIO denied information on the grounds that the information sought was in contravention to section 8(1) (j) of the RTI act. The FAA has upheld the decision of the PIO. The applicant has approached this Commission.

Decision:

3. Mr Hans Kr Khanan - AO , officer representing public authority stated that the appellant was a student of the Institute and that he was caught resorting to unfair means in his M.Ed and again in M.Com examination upon which his entire result was cancelled. His relations deteriorated with the Institute and he started filing mass RTI applications with motive to harass the Institute.

4. Mr Hans Kr Khanan - AO also stated that the Commission has admonished this appellant in its earlier decision dated 19.02.2016 in CIC/CC/A/2015/003189 and rejected all his appeals. The officer stated that the repetitive misuse of RTI Act by this disgruntled applicant who is filing RTI in his name and in name of others like Ms Shweta Saini. The appellant is harassment to the Public Authority and he is an unreasonable trouble maker for the Dayal Bagh Educational Institute. Hence, all appeals of this appellant are rejected.
