The meeting started with opening remarks of the Chairman. Secretary welcomed all the members and offered thanks to Supreme Father. Following are the items discussed and decisions taken.

02/ BoG Jan-19	 A. Action Taken Report was noted. It was suggested by Prof. Naga Bhushan Rao, Mentor TEQIP that a table with detail of each item procured along with its usage and its impact on academic and research be prepared as it will be very useful in submitting the TEQIP Project outcome. B. Presentation of report of TEQIP-III activities: Procurement, Academic Twinning, IOC, and Audits (Financial Audit and Performance Audit) The Chairman and members advised that there should be no further delay in implementing the project having expressed concern at utilization of only about Rs. 1.35 crores till date out of Rs. 10 crores. Committee members pointed out the need for more efficient working by the TEQIP team, in particular the following: Improvement in involvement, planning, coordination, cooperation and execution among project director, coordinator and member secretary. Timely holding of BOG meetings, the current one being held after a gap of six months. Improvement in presentation of review of past activities to BOG. The review presented in the current meeting was sketchy. A tracking mechanism needs to be implemented for all activities under TEQIP III including money being spent, academic activities and others. Constraints of manpower to be resolved innovatively. Research scholars to be well utilised for teaching assignments across the faculty while ensuring that teaching quality is not compromised. A note may be prepared outlining internal constraints and suggested means to overcome these innovatively. Further, voluntary help from large pool of Alumni may be taken in different academic work including teaching assignments. Proper formats may be designed for presenting proposals to BOG so that justification and linkage with overall TEQIP objectives are brought out clearly.

Additional action points are as under:
