MINUTES of the emergent meeting of the Board of Management (Governing Body) of the Dayalbagh Educational Institute (Deemed to be University) held at 1.00 P.M. on 15.10.2022 (Saturday) in the Committee Room, Central Administrative Office of the Institute.

1. Considered the request of former teaching staff members to review the penalty imposed by the Governing Body (Board of Management) vide Resolution No. 22(a) dated 27.8.2022.

The members were briefed that only two teaching staff members viz. Prof. Gunjan Agrawal and Dr. Amla Chopra have submitted their request for reviewing the penalty vide their application dated 7.9.2022 and 6.10.2022 respectively. The members have expressed the opinion to review the case of Prof. Sant Prakash also on the same lines observing the principle of equality despite the fact he has not submitted his request.

The members after deliberating this matter at length arrived at a consensus that the penalty of "Dismissal from Service" needs to be mitigated in the interest of the family members of three teachers viz. Prof. Sant Prakash, Prof. Gunjan Agarwal and Dr. Amla Chopra keeping in view that the earlier imposed penalty would deprive them of retirement benefits as per rules of the Institute.

Resolved that the penalty of "Dismissal from Service" earlier imposed vide R.No.22(a) dated 27.8.2022 be and is hereby approved to be mitigated, as the Compulsory Retirement in the interest of the Institute \& the public for maintaining discipline and administrative efficiency. Prof. Sant Prakash and Prof. Gunjan Agrawal shall be entitled to the consequential retirement benefits at a rate of two-thirds of full superannuation pension and gratuity admissible as per rules. The case of Dr. Amla Chopra will be governed by National Pension System (NPS) and no other superannuation benefits will be admissible to her.
