Eligibility: A person who has obtained a degree or diploma from DEI including its three erstwhile colleges,

Any member of the Institute or its administration who has served/been associated with the Institute for at least 10 years, the concerned member be treated as alumni of the Institute.

(As per Academic Council & Board of Management (Governing Body) resolution no. 7 dated 19.4.2018 & 20.4.2018 respectively).

Nomination: Any member of the Association of Alumni of the Dayalbagh Educational Institutions (Registered) or any faculty member of the Dayalbagh Educational Institute (Deemed to be University) can propose names of eligible candidates with bio-data.

Selection Process: A Selection Committee consisting of the following members shall short-list a few names and submit the same to the President, Dayalbagh Educational Institute:
