NOTICE

The Lateral Entry (LE) scheme for upward mobility to higher programmes is one of the lateral pathways that the Institute offers to its meritorious students of various Certificate level programmes. The students of Certificate Programmes who fulfill the below mentioned eligibility criteria shall be allowed to appear in selection examinations to be held for the LE scheme for possible upward mobility from Certificate Level Programmes (**Source Programme**) to Diploma / B.Com. (**Target Programme**).

Eligibility criteria for short listing students from Source Programme:

1. Certificate Level (High School or Intermediate students): Top 20% students as per CGPA of 4 modules of each centre in the order of merit with a minimum of 6.00 CGPA.
2. Certificate Level Programmes relating of Office Management stream: Top 20% students as per CGPA of 4 Modules of each centre in the order of merit with a minimum of 6.00 CGPA.



Important Operational Details:

- (1) All communication with the eligible students shall happen through email or through website notice.
- (2) List of students eligible for Lateral Entry Scheme is notified on website. In case any student has a query regarding his/her name not appearing in the list may send email on **deicart.ic@gmail.com**.
- (3) The schedule of **Lateral Entry Test** is given in **Annexure-1** of this notice.
- (4) The selection process is a 2-phase process consisting of Written Test and Personal Interview. Qualifying students will be eligible for an Interview. After the interview, list of selected candidates to the Target Programme shall be notified.

- (5) The test shall be conducted in an online mode with supervised mode through a third-party service provider. All the eligible students whose names are mentioned in the **Annexure-2** shall get a test link and credentials one day before the scheduled test. Accordingly, all the students shall report in person, along with their Smart-Phones/ Laptops, at the specified venue as mentioned on the attached **Annexure-1**.
- (6) All eligible students will receive a video link (on their email-id) consisting of tutorial of how to attempt the online test.
- (7) The syllabus for lateral entry test for upward mobility into First year of Diploma in Engineering (three-year course), like, Automobile, Civil, Electrical, Electronics, Leather Technology (CASD), Mechanical, etc., will be the same as notified for the entrance test held for admission into the Diploma in Engineering programme of the Institute and which is available on the Institute website, whereas the duration for its lateral entry test will be $1\frac{1}{2}$ hour (90 minutes).
- (8) The syllabus for lateral entry test for upward mobility into First year of B.Com. will be the same as notified for the entrance test held for admission into the B.Com. Programme of the Institute and which is available on the Institute website, whereas the duration for its lateral entry test will be $1\frac{1}{2}$ hour (90 minutes).
- (9) The syllabus for the lateral entry test for upward mobility into Second year of corresponding Diploma in Polytechnics, like, Interior Designing & Decoration/ Textile Design/ Garment Technology/ Modern Office Management & Secretarial Practice, etc., will be the same as prescribed for the curriculum for the first four modules (first year) of the respective Diploma in Polytechnic programmes, whereas the duration for its lateral entry test will be One Hour (60 minutes).
- (10) The eligible candidates will have to submit their CCA Certificates during their Interview to the representative of Interview Committee.
