(3) All qualifications and experience will be considered as on the closing date, i.e. the last date of submission of Application form. (4) Candidates are called for the Seminar-cum-Presentation and Interview on the recommendations of the screening committee of the Institute and as such all applicants may not be called for Interview. (5) The Institute reserves the right to fill, to fill on Temporary/Contractual basis, or not to fill any of the posts, without giving any reason whatsoever. (6) The Institute may also give appointment on a Contractual/Temporary basis as per norms. The number of posts may vary depending on exigencies.
