- 6. Bidders should be OEM/Authorized partner/Authorized dealer of OEM. In case of Key project/Contract or High Value Machines/Plants, the Performance Security is required to be submitted by the successful bidder between 5-10% of the value of the order or contract in the form of FDR/Bank Guarantee or authorize the Institute to deduct aforesaid amount from the bills as performance guaranty/security.

- 8. In case opening date of Tender happens to be holiday, tender will be received and opened on the next working day at the same time and same place. EoI received after the closing date will not be entertained.
- 9. The Institute is not bound to accept the lowest rate or any other offer and the acceptance of the offer is entirely at the discretion of the Committee.
- 10. All purchases are subject to the approval of the Governing Body of the Institute.
- 11. The Institute reserves the right to select certain items in single or multiple units and reject the others or all as mentioned in the schedule and to revise or alter the specifications before acceptance of any EoI and accept or reject any or all EoI, wholly or partly or close the EoI without assigning any reason whatsoever.
- 12. Arbitration and Laws: In case of any dispute or difference arising out of or in connection with the EoI conditions / order and Contract, the Institute and the Supplier will address the dispute / difference for a mutual resolution and failing which, the matter shall be referred for arbitration to a sole Arbitrator to be appointed by the Institute. The Arbitration shall be held in accordance with the provisions of the Arbitration and Conciliation Act, 1996 and the venue of arbitration shall be at Agra only. The resolution of the Arbitrator shall be final and binding on both the parties.
