The Commission will provide the following allowances to.Dayalbagh Educational Institute, Dayalbagh, Agra - 282110 in respect of Dr. Ranjit Kumar towards his visit to U.S.A.

1.	Fellowship amount of US \$ 3000 per month
2.	Grant of US \$ 600 to travel within USA upto 6 Months
3.	Contingency Rs. 50,000/- to cover expenses for visa, airport, transfer, medical insurance

The University/College is, therefore, requested to arrange his/her air tickets from the nearest International airport in India to the nearest airport to the place of work in USA and back (by excursion category for the whole sector or a part thereof, if available, otherwise by economy class shortest route) directly by Air India. The expenditure incurred on International air-fare is reimbursable by UGC.

Visa fee paid by the scholar is also reimbursable on production of receipt issued by the Embassy/High Commission. However, service charges claimed by the travel agent are not reimbursable.

The University/College may provide him funds for his/her travel from his place of duty to the nearest International Airport in India and back as per his/her entitlement.

The Commission will also reimburse the expenses incurred by the University/College on his/her road transport to and fro between his/her residence to airport/railway station.

No other expenses will be reimbursed by the University Grants Commission.

A proforma for the report by the scholar on his/her visit is enclosed. This may kindly be got completed from the scholar immediately after his/her return and sent to the University Grants Commission. The claim should reach the UGC office within 90 days after the completion of the visit.
