



In case the candidate has qualified under RA (Result Awaited Category), the certificate will be valid only from the date of acquiring the requisite qualification as stipulated in the notification. The details regarding the eligibility criteria for this test are given overleaf.
- In case the candidate does not fulfil any of the eligibility conditions and Caste/PWD status (wherever applicable), this certificate may be treated as cancelled.
